MUSEUM PURCHASE AWARD

Exhibited works will be offered to the Philadelphia Museum of Art. The maximum payment to the artist for the Purchase Award (funded by Perkins Center) is \$600.

requirements

Artists are invited to submit a maximum of three works that have been created within the past three years. **The fee is \$8 per entry.** Works previously shown in a Perkins Center annual juried exhibition will not be accepted.

Framing Information & Instructions

1. **All entries must be framed and wired on back.**

2. It is **strongly recommended** that submitted works be (a) framed according to professional standards (b) covered with glass or plexiglass.

The following are unacceptable:

(a) 2 pieces of glass or plexiglass joined together by clips.

(b) plastic frames with cord that serves as hanging mechanism (poster frames).

3. Works larger than 24" x 36" (or 36" x 24") should be covered with **plexiglass** rather than glass. If such works are not covered with **plexiglass, they will not be insured.**

Size Requirements

Maximum framed size: 60" x 60"

Maximum weight: 50 lbs.
